MINUTES OF THE CRANE COUNTY APPRAISAL DISTRICT BOARD OF DIRECTORS

The Board of Directors of the Crane Co. Appraisal District met on Wednesday, June 3, 2026 at 1:30 p.m. in the board room of the School Administration Building at 511 W. 8th St. Crane, TX.

Those attending were Judy Crumrine – Vice Chairman, Emily Barton – Secretary/Treasurer, David Whitaker - member. Others present were Byron Bitner - Chief Appraiser and Kelly Lee of the Appraisal District.

1. Judy Crumrine called the meeting to order at 1:37 p.m.
2. David Whitaker made the motion to approve the minutes from the March 11, 2026 meeting. Second by Emily Barton. Motion carried unanimously.
3. Emily Barton then presented the Treasurer's Report with a checking account balance of \$306,769.71 as of May 31, 2026. March's Interest was \$777.92, April's Interest was \$800.86, and May's Interest was \$793.21. David Whitaker made the motion to approve the Treasurer's Report as presented. Second by Judy Crumrine. Motion carried unanimously.
4. The Board of Directors then reviewed all bill payments from March 1, 2026. Emily Barton made the motion to approve all bill payments as presented. Second by David Whitaker. Motion carried unanimously.
5. Byron Bitner then presented to the Board the changes made by the Chief Appraiser per Sec. 25.25b of the Texas Property Tax Code.
6. Byron Bitner then presented to the Board the proposed budget of \$640,000 and salary estimates for 2027. Emily Barton made the motion to approve the 2027 proposed budget and salary estimates as presented. Second by David Whitaker. Motion carried unanimously.
